A USTRALIANS were taken aback last Wednesday when they were confronted by the sinister spectacle of three white-hooded members of the Ku Klux Klan splashed across the front page of *The Age*, complete with flags and logos representing the blood of Jesus and a black Christian cross.

A 130-year-old American organisation which epitomises race hatred and bigotry, with murder and terror as its methods of operation, the KKK has come to Australia.

Lest anyone be tempted to dismiss the KKK as an anachronistic curiosity, just a few months ago in the obscure American town of Jasper, Texas, two skinheads chained James Byrd — a 49-year-old African-American — to the rear of a pick-up truck and dragged him for two kilometres along a dirt track. His body smashed into a culvert, the impact severing his head, right arm and shoulder. One of the skinheads, 24-year-old John King, who was sentenced to death for the hideous deed, had planned to establish a branch of the KKK in Jasper and had been intent on making a political statement.

Lest anyone harbour any illusions about the extent of the scope of the KKK's racist agenda, a recent publication put out by the Imperial Klans of America articulated the organisation's stance on Jews beyond any doubt.

"Basically, a Jew is a mongrel," it stated. Jews are "chosen to be burnt, consumed by fire;" they are "evil and wicked;" and "God condones the genocide of the

Jewish race." The KKK's target list of hate groups includes Jews, Catholics, gays, various ethnic communities and Communists, while a number of allied Australian groups have proclaimed Hitler's ideology to be "the soul of our movement," while promoting the concept of a "racial holy war" and extolling the virtues of "gassing the Jews."

The objective of drawing attention to this insidious organisation and its credo is not to sow undue alarm within the community. Indeed, there is a strong case to be made and it has been repeatedly during the past week in regard to the extensive media coverage that the KKK has been receiving since its presence in this country was exposed that by according it the oxygen of publicity, the media is playing directly into its hands, effectively acting as a recruiting agent and providing a vehicle through which its message is being actively promoted. All true. Indeed, it is quite likely that the KKK will have attracted additional members as a result of its dogma being trumpeted far and wide in the past week.

This issue of whether to give publicity

to undesirable elements in our society, and if so, how much is reasonable and how much is excessive is a perennial dilemma for responsible media outlets. There is no question that the avalanche of media attention which Pauline Hanson received in the wake of her inaugural parliamentary speech propelled her into the forefront of public awareness and boosted her standing far in excess of that which she warranted, in the process generating support for her cause.

BUT WE must not lose sight of the bigger picture. It is imperative that the existence of an organisation in our midst such as the KKK be known, and that its bigoted message be exposed and understood in all its implications and ramifications. The Imperial Klans of America, which are based in Kentucky, have have established branches in New South Wales, Victoria and Queensland; a second KKK group, the New Order Knights, based in Montana, is also believed to be planning to set up a chapter in Australia.

Secrecy lies at the heart of the KKK's

modus operandi; the very reason that Klansmen adopted the practice of wearing robes, sheets and hoods was to conceal their identity during their murderous attacks on African Americans, white sympathisers and civil rights workers during the latter years of the 19th century. Shedding light on such organisations — on their ideology, on their beliefs, on their membership and on their operations — can only serve to forewarn and forearm those who could be the targets of their hate, not to mention the authorities and society itself, whose very fabric is threatened by their noxious presence.

Also illustrative is the subtext at work here — the tacit connection between the KKK and One Nation. While One Nation took steps to expel Exalted Cyclops Peter Coleman once his KKK ties were publicised, there is no question that the party's strong performance in both the recent NSW and federal elections was built on the identical fertile territory which the KKK is now exploiting in establishing a beachhead in Australia, each complementing the other's implicit and explicit messages.

As a number of Jewish leaders have cautioned, it is important not to lose perspective. There is no cause for consternation. But it does not require large numbers to spread hate nor create unrest. The KKK in our midst is a malignant presence which needs to be closely watched.

Representation and the JCCV

IT IS very troubling indeed when the non-elected, non-representative but self declared roof-body of Victorian Jewry, the Jewish Community Council of Victoria (JCCV) acts against the interests of democracy. 
